Non-publication order

[7] The Chair reminded those present at the hearing that non-publication orders were in place. The non-publication order covers all parts of the proceedings other than the names and descriptions of the parties to the matter, or the particulars of the premises affected, as set out in section 203(5) of The Sale and Supply of Alcohol Act 2012 ('The Act').

Object of the Act

[84] Our conclusions on the suitability of Mr Michael Jaz are illustrative of our lack of absolute confidence or faith in the ability of the Applicant to meet the dual objects of the Act. The object of the Act is that the sale, supply and consumption of Alcohol must be undertaken safely and responsibly, and that any harm caused by the excess or inappropriate consumption of alcohol should be minimised. We find, after viewing the video evidence presented, ultimate failure on

the part of a Licensee. Standing back and looking forward we have asked ourselves whether we are satisfied that the Applicant will meet the dual objects of the Act. Based on the evidence presented at the hearing we are not satisfied that the object of the Act was or will be met...

Decision

[85] For the reasons above, having had regard to s131 of the Act, we decline the application by Jaz Holdings Limited for the renewal of an on-licence for the restaurant known as 'Venuti', located at 791 Colombo Street, Christchurch.

[86] The licence expires at 5.00pm on 20 February 2023.
