Group Round: Introductions and news from each agency.

Previous Notes, Matters Arising:

Otakaro / Avon River Corridor Regeneration Planning is continuing, and includes disability sector representation.

The Canterbury Accessibility Charter work at the Council is on target, with the staff working group submitting a September report to the Executive Leadership Team, followed by Councillors' briefings.

The timeline that Barrier Free NZ Trust and the Earthquake Disability Leadership Group have for launching the Charter to the public, with foundation signatories, is November 2017.

Digital Team: Accessible Web and Maps

Digital Team sought advice about accessible events listings on the "Be There" site: how to define accessibility, and how to depict online what accessible services are available at an event.

Any list would also act as a prompt for event organisers in relation to the accessibility of their event.

Discussion about correct language to use and how to keep prompts succinct (without too much text) while still being clear.

The DAG members indicated key categories. These included: mobility carparks; accessible toilets; hearing loops; NZ sign language interpreters. It was also suggested that encouraging the inclusion of maps / photos / other guidance, can assist people planning to attend an event. Additionally, accessible routes could be indicated; and information about discounts relevant to people with disabilities, e.g. support people.

Staff will circulate a list to the DAG for feedback.

Recreation and Sport: Sporting facilities, changing places, accessible features

Discussion about the Changing Places (accessible changing rooms) model. In partnership with CDHB, testing of changing rooms design / functionality has taken place in their Design Lab. Discussion about best practice at the beginning to avoid expensive retrofitting.

Parking

People need to be aware of the eligibility criteria for mobility parking permits, and encourage people to apply.

There is a history of mobility parking concerns surrounding, and within, the hospital grounds. Since the earthquakes and rebuilds there are increased concerns. The DAG saw the problem as having joint responsibilities with the CDHB and the Council. Discussion included whether there is a way to make the services more accessible, in addition to providing more car parks.
