### Coastal-Burwood Community Board Outcome

"Community safety and wellbeing are supported."

#### Why we want this

There have been many changes across the Board area since the impacts of the earthquakes, the demographics and makeup of communities have changed along with the land. People want to continue to live and work in the area, to be part of the community and feel safe in their own home and community.

#### What the Board will do

- 1. Support community initiatives that increase and support community safety and encourage use of spaces.
- 2. Work with local and citywide groups and agencies that focus on crime prevention or increase and support community safety. e.g. the Aranui Neighbourhood policing team, Burwood Community Car Watch and Neighbourhood Support.
- 3. Support community connections amongst residents to increase neighbourhood safety and support, e.g. Neighbourhood Week.
- 4. Advocate for recognition and support from health and government sources for members of the community with mental health issues and stress disorders especially those resulting from the ongoing impact of natural disasters and hazards.
- 5. Support community initiatives responding to and supporting members of the community with mental health issues and stress disorders especially those resulting from the ongoing impact of natural disasters and hazards.

We will measure our success by

- 1. Identifying projects , plans, organisations and activities that have been supported by the Community Board in the wards.
- 2. Graffiti reduction in the area is monitored.

### COMMUNITY PREPAREDNESS AND SAFETY

"The community will be supported to be prepared to respond to and recover from the impacts and consequences of natural hazards."

#### Why we want this

The Coastal and Burwood wards are susceptible to many natural hazards including coastal erosion, flooding, land instability, liquefaction, fire, earthquake and severe weather events. Our community's have told us the importance of protecting each other and their homes in the event of natural disasters and hazards. They want to be supported to know more about possible events, being prepared and what to do. The Board also acknowledges that it has a role in climate change leadership.

#### What the Board will do

- 1. Will work with Civil Defence and other emergency services to better understand their procedures in response to a variety of natural hazards across the ward and how this works for our community's.
- 2. Will support community initiatives to increase emergency preparedness across the ward areas including the development of localised community resilience and response plans.
- 3. Advocate for the development of a coordinated approach or plan to response and recovery across the area.
- 4. Support community education and awareness initiatives about natural hazards to support individuals in their response to and recovery after, natural hazards and emergencies.
- 5. Actively seek to put in place and advocate for flood mitigation and good drainage in the Coastal and Burwood wards to future proof against erosion and flooding.

We will measure our success by

- 1. Will be able to identify communities with resilience or response plans in development or completed.
- 2. Will be able to show how and where natural hazard/emergency response education and awareness opportunities have been offered across the wards.
- 3. Will show where the Board has supported and advocated for drainage and flood mitigation in Council plans and projects.
- 4. Feedback from our communities on how well they feel they are prepared and how well they are prepared, for future disasters/events.

### What is a Community Board?

Community Boards were created by the local government reforms in 1989. Over 100 community boards now operate in both urban and rural areas within local authorities throughout New Zealand. They carry out functions and exercise those powers delegated to them by their councils. Local body elections for Community Board members and Councillors are held every three years.

Coastal-Burwood Community Board

The Community Board's main role is to:

- Ø Represent and act as advocate for the interests of its community.
- ${\it \varnothing}\,$  Consider and report on all matters referred to it by the Council, or any matter of interest to the Board.
- Ø Maintain an overview of services provided by the Council within the community.
- Ø Prepare an annual submission to the Council for expenditure within the community.
- ${\it \varnothing}\,$  Communicate with community organisations and special interest groups within the community.

The total Board area is located in the east side of Christchurch and covers the area from Brooklands in the north, inland to Marshlands Road, and along the coast to South Shore. The community takes in Brooklands, Spencerville, Prestons, Burwood, Parklands, Queenspark, Shirley, Dallington, Burwood, Horseshoe Lake, Westhaven, Waitikiri, Windsor, Tumara Park, Travis Wetland, Avondale, Aranui, Wainoni, Bexley, Northshore, North New Brighton, New Brighton, South New Brighton and Southshore.

- 7. Advocate that appropriate service levels are set.

- 1. Identifying the Parks Management Plans that have been updated and how they reflect the current needs of community.
- 2. The number of local and citywide events and gatherings that are held and/or supported in the area.
- 3. A Master Plan for QEII Park will be in development.
- 4. Identify cycleways, walkways and natural spaces that have been developed, planned, activated or completed.
- 5. Reports by staff to the Community Board on service levels.








#### Why we want this

Community facilities, events and initiatives are focal points in the community which play a role in increasing community participation, building community capacity and creating stronger local communities. They fulfil a wide range of social, educational, recreational and physical needs and well-connected people help build strong and supportive communities and promote resilience.

#### What the Board will do

- 1. Support community-led initiatives that promote the activation of community places and spaces (e.g. Support A-Town repair of facility, ACTIS partnership to activate the Aranui-Wainoni Community Centre).
- 2. Identify community priorities and support, through funding, events and initiatives that facilitate creating a strong, connected community. e.g. I Love New Brighton, Parklands @ Play, Neighbourhood Week, Burwood event (new) and community and garden awards.
- 3. Undertake a snapshot of community facility needs across the ward to inform the development of a ward wide facility plan. We will work to ensure that we have sufficient facilities that contribute towards making our communities vibrant, connected and safe, advocating for Council facilities and services to be provided appropriately to meet local needs.

We will measure our success by

- 1. The Community Board has supported events and activities in the ward that encourage community involvement and connectedness. This could be through funding and/or involvement.
- 2. Having a completed facility review across the ward that will outline and prioritise Community Board support for the community facilities to meet community needs.
- 3. Identifying projects in the area that meet community needs in terms of activation of places and spaces that the Community Board have supported.
- 4. Community events are held and feedback will be given by the community from event evaluations.

The transport system is well designed and meets the needs of community and visitors alike, particularly in the regenerated areas.

#### Why we want this

A varied and well designed transport system opens up a community or area providing people with access to economic, social, cultural and recreational activities, opportunities and connections. The natural landscapes of our area lends itself to the development of "active" transport pathways such as cycleways, walking and running tracks and paths. Good bus routes that meet a variety of community needs are essential for those dependent upon public transport.

What the Board will do

- 1. Support plans and projects that increase or improve Coastal-Burwood transport systems.
- 2. Advocate for our transport system to be functional, aesthetically pleasing and multi-purpose (e.g incorporate walking/cycle trails) as well. An example are bridge approaches, they are gateways to our community and beautification through plantings and artwork should be considered. e.g. Godwits sculpture on Bridge Street, ANZAC Bridge/Fronds.

We will measure our success by

1. Feedback from the community with regards to how the transport system meets their needs.

### ENGAGED COMMUNITIES THROUGH PARTICPATION

#### Why we want this

Our communities saw significant changes in and damage to our infrastructure after the earthquakes. In rebuilding our communities we have a unique opportunity to make changes and improvements to our infrastructure based on the knowledge of experience and use. Some infrastructure has still not been repaired and the Board will advocate for these repairs to ensure our infrastructure better meets the needs of our community and is more attractive and resilient. We also want our area maintained to acceptable levels.

#### What the Board will do

- 1. Advocate for well designed urban areas that form a hub for the community e.g. regeneration of New Brighton, Southshore and South Brighton.
- 2. Advocate for the completion of earthquake repairs to roads, footpaths and other infrastructure, the ongoing maintenance of existing infrastructure and the redevelopment of the former red zones.
- 3. Advocate for affordable, appropriate levels of housing and healthy homes that meet community needs.
- 4. Advocate for environmentally and culturally appropriate infrastructure for well functioning communities and good quality of life.
- 5. Partner with Development Christchurch and Regenerate Christchurch.

#### We will measure our success by

- 1. The Board worked with Development Christchurch and Regenerate Christchurch.
- 2. Board priority infrastructure projects are advocated for in the Council's Annual and Long Term Plans.

#### Why we want this

The community are a valuable source of knowledge and information. Decisions and plans made are more sustainable and successful when the community are involved.

#### What the Board will do

- 1. Where possible and practicable local participation, knowledge, experience and feedback will be sought for Council and Community Board projects and plans.
- 2. The Coastal-Burwood community Board will provide communications to the community about what's going on in the area and things with a citywide impact.
- 3. The Coastal-Burwood Community Board will make themselves available for contact by the community, will attend community events and residents association meetings as possible and have an open public forum once a month at a Board meeting to allow community to drop in and discuss current and urgent issues.
- 4. Support opportunities for community's to network and board members attend these opportunities as appropriate.
- 5. Develop an annual Coastal-Burwood Community Board Community Report .

We will measure our success by

- 1. Listing the opportunities provided for the community to be involved in Council Community Board projects and plans and identifying when community involvement influenced and or supported decisions annually.
- 2. List meetings and networks attended and hosted by the Community Board that provided opportunities for two way communication and discussion annually
- 3. Recording the number of publications and communications the Community Board have input into or provide to the community annually. e.g. The Community Board newsletter.
- 4. Feedback from the community through a stakeholder/residents survey.
