You requested the following information, under the Local Government Official Information and Meetings Act 1987 (LGOIMA):

Under the Local Government Official Information and Meetings Act I request the following information (request 1):

The job titles of staff, ordered by seniority, with a total remuneration of equal to or more than one quarter of a million dollars annually, as at 30 September 2019.

As a separate request (request 2):

The amount each of those persons is remunerated annually.

If you refuse request 2, please nevertheless provide the information requested in 1.

Response:

Please note the information we are providing is at today's date of November 26 2019. The reason for this being that at September 30 2019, the General Manager Citizens & Community was the Acting Chief Executive.

All of the individuals listed below sit on the Executive Leadership Team and as such, apart from the Chief Executive, there is no hierarchy or seniority within the General Managers (GM) – they are equal to each other. Accordingly we have listed the General Managers in alphabetical order.

Please note we are withholding the amount each person is remunerated annually under the following section of the LGOIMA: 7(2)(a) – to protect the privacy of natural persons.

However, to ensure that public interest is met we are providing the indicative salary range. This is following previous advice we have received from the Ombudsman who considers that the disclosure of the salary range for each role adequately addresses public interest.
