Thank you for your email, received on May 15 2019. You requested the following information, under the Local Government Official Information and Meetings Act 1987 (LGOIMA):

- 1. Whether councillors are entitled to free and/or discounted parking (if the parking is discounted, how much is the discount per car park?);
- 2. Whether other staff are entitled to free and/or discounted parking (please provide a list of job titles);
- 3. The location(s) of the free and/or discounted parking available to councillors and/or other staff;
- 4. The market value of the free and/or discounted car parks available to councillors and/or other staff.

## Response:

Acting Head

- 1. The Mayor and Councillors are provided free car parking at Te Hononga/the Civic Building.
- 2. Some senior staff are provided free car parking at Te Hononga/the Civic Building, and in the adjacent Canterbury Club carpark. Car parking is provided to some senior managers. It is also provided to some staff to facilitate access for those who are required to work late hours (for example overnight customer service staff), those on rehabilitation or those with disabilities. The Christchurch City Council has a sinking lid policy for the supply of new car parking for staff and the number eligible is decreasing over time.
