A. Point of sale software prompts operators to confirm age and locks the sale until a supervisor release's it. Our customer services team are trained to watch out for multiple purchases by "at risk" customers, in addition to any attempts to purchase alcohol by intoxicated or underage customers

B. We will Display signs detailing the Statutory restrictions on the Supply of Alcohol to minors and the complete prohibition on sales to intoxicated persons

C. The Owner Operator of New World Durham Street will sell Beer and Wine in accordance with the Off licence issued.

D. We use a Web based training system – Red seed that requires all our Customer Service Team members to undergo training and then complete an online test covering the sale of Liquor. The course is called "Sale of Alcohol". A copy of the script can be obtained from kelly.chapman@fssi.co.nz

E. New World Durham Street keeps within all known District Authority Noise Levels.

F. We have no knowledge of any deviant, antisocial and disruptive behavior resulting from the Sale of liquor at New World Durham Street

G. In the surrounding Area we have licensed Restaurants, Bars and Liquor Wholesalers. New World Durham Street has operated with a Liquor Licence on these premises for many years. Simon and Joanna Turnbull have operated New World Bishopdale, New World Ferry Rd and Raeward Fresh Tower Junction and are responsible operators approved by Foodstuffs South Island Ltd. The granting of this Licence will not contribute to an increase in Alcohol related problems in the area

Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

14. Processing Timelines:
