All staff are able to call taxis, utilise the Willowbank shuttle and can call uber for customers if necessary. Bus timetables are also available.

 - Ensure we have checked ID, food readily availbe and promoted. Staff all trained in safe drinking practices. Manager/license holder always on site.
- d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Only staff serving alcohol are fully trained with a license holder in cafe. Clear signage in regards to alcohol rules. ID checked. Free water/food offered.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations)

Water station for customers to help themselves to. Filtered water on tap with glasses/bottles for customers to use. Prominent position by coffee machine in cafe.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Fully managed by fully trained/licensed staff. If younder staff on till they must check with supervisor regarding all liquor sales.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Not applicable as cafe is located inside the reserve.

- h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?
 - Cafe is locate within the reserve off the main road. The gates are locked in the evenings to prevent vandalism.
- i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The closest cafe is 1km away - don't expect any issues

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Mainly rural, closest house is 200m away. The granting of a license will not impact the changing of neighbouring land use.

12. Important to note - Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

- 1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council.
