We have a sign on display to encourage alternative transportation and our staff are trained to offer contact information to taxi/cab agencies to offer assistance to patrons or call themselves.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Signage and enforcement that intoxicated persons may not be served nor remain on licensed premises. Staff have been instructed in how to recognize the signs of escalating intoxication. Alternative drinks and food will be recommended. No promotions that encourage consumption

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Staff are trained to actively assesses our customers cognitive state and age to decide whether it is appropriate that person be served or have I.D. check.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Free water is available at water cooler (provided by Celebet Water) and visible with signage.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

We keep an LCQ training course book on-site for all staff to review and ensure a clear understanding of the act and appropriate behavior and rules. This also acts as an available resource when facts need to be referenced. Our Host Responsibility Policy Plan is studied by all staff.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

All event hosts work with the manager on-site to mitigate any excessive noise issues, leaving the volume to our qualified sound engineer. We have rearranged the space which has stopped noise complaints, and currently working on installing appropriate soundproofing/insulation.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We have had no serious issues in 11 years. We've dealt with vandalism in the past as we are not in a very public area, making us an easy target. We've installed a security system, cameras, and signage to deter criminal behavior. We call 111 in the case of any emergency.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There is a pub 1-2 blocks away. As our main function is not a bar/alcohol sales, we expect to continue to have minimal issues in the area.

Business close by are all car and motorcycle repair businesses that operate during the day. Our sale of alcohol and time of our events does not affect the operations of the businesses in the area.
