We will put few transport signs around counter and somewhere inside of shop such as "need ride?" and "can we call you a taxi?", we will training staffs to encourage customers use a taxi or uber service if they needed.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

we aim to promote responsible alcohol consumption. As such, we never offer discounts of more than 25% on alcohol beverages. Additionally, we include message encouraging responsible drinking in our promotions. Such as "know your limit" and "drink responsibly". To avoid encouraging excessive drinking, we will not depict people consuming multiple drinks quickly in our advertisements. we will also promote non-alcoholic drinks to reduce the risk of harm and prevent drink spiking.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

we are committed to ensuring that alcohol is never sold prohibited individuals. If a customer appears to be underage we will request a valid, legal form of identification to verify their age. All staff members will be trained in the SCAB technique to assess customers' conditions accurately. Any intoxicated person will be refused service and asked to leave the premises. if necessary, we will involve the police to handle the situation.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Water will always be provided and free of charge. Served in water jugs for our customers. We will make sure water jugs always filled and they are all in near the counter for self-service. we also can bring to customers if they needed.

Our duty manager will train our staff regarding the host responsibility policy and record training is kept.

Currently it is 71.4 db inside of shop when fully seated and quiet from outside. We will not making noise for community as we closed 4pm everyday.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We have not experienced any nuisance or vandalism since opening our shop. However, to prevent any future incidents, we have implemented a security system. We have installed CCTV camera as both inside and outside and outside the shop. If necessary, we will not hesitate to contact the police for intervention.

only one New world supermarket 1km from us. this will not increase any alcohol issues as we are different type of licence and trading hours.
