Safe transport options are covered in our training guides to all staff and appropriate signage is on display within the premises. The premises is directly opposite the Christchurch Bus Interchange

Hoyts does not promote any excessive consumption, so the following are not allowed within our venues. Drinking games, drinking challenges, alcohol promotions involving travel or where an item is discounted more than 25%

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Service ticketed guests, or guests of pre-arranged functions only. Proof of age will be required from anyone who may appear to be under the age of 18. Refuse service to anyone who is intoxicated. Employees will monitor guests during before and during screenings

Water is freely available from the bar for any patron and displayed as such

All alcohol service, whether from bars, at functions will be governed by the applicable licensing regulations, including RSA. Only staff aged 16 and older will be permitted to sell, serve or have access to alcohol. Additionally all staff are trained using internal systems for RSA

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Being a cinema the tenancy has heightened sound proofing to restrict sound bleed from each cinema to the exterior. In addition the cinema is located within the Westfield Shopping Centre further restricting noise to the exterior area.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

No known level of nuisance or vandalism for this location. Hoyts Christchurch Entertainment Exchange cinemas are located within a shared building and therefore has security and supervision for the immediate surrounds to minimise any nuisance or vandalism

Within the Building there are other Licensed premises including The Diversity a pan-asian restaurant and Holey Moley Golf Club and Archie Brothers Cirque Electric entertainment venues

The premises is located in an entertainment and dining precinct of Christchurch. Surrounded on 3 sides by retail, education (Canterbury College) and office buildings, and opposite the Christchurch Bus Interchange. The Christchurch Central Police Station is one street over.
