Prohibit sale of Alcohol to minor by ID check, Be aware of intoxicated person buying alcohol. Make sure to promote sale of food items along with alcohol purchase, offer tasty drinks that are cheap and non-alcoholic.

strict ID check (accept only NZ driver licence, NZ passport, overseas passport or ID card). Checking the level of intoxication of person purchasing the alcohol. We cannot serve prohibited person or allow them to remain on the premises.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Staff are trained to provide cups of water if a customer asks for. We don't have a station ready for free water but restroom is open to public as well as the cup.

Staff will be trained so they can identify prohibited people and provide the correct information and service to customers.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

As an indoor store, we do not produce any levels of noise, and there are currently no issues with noise levels.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

None, as a normal grocery store there is no levels of nuisance/vandalism. If such occur, we will talk with the offender and try to resolve the issue as calmly and quickly as possible.

There is a Liquorland (Bottle store) near the proposed premises. And we will ensure that the proposed use of the site complies with the Council's district plan. And Kosco has always been selling foreign alcohol with low alc% intended for Asian drinking style.

The land near the proposed premises is used for retail. The granting of a licence for our premises will not impact on changing neighbouring land use.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
