b. What steps does the applicant propose to take to provide assistance with or information about alternative forms of transport from the club, for staff and patrons?

Signs will be displayed and staff will be informed of the appropriate responses informing patrons that both taxis and ride-share apps will work in the area.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Monitoring the consumption area and ensuring patrons are only consuming alcohol within the stated area. Always having a duty manager on shift when alcohol is being sold who will take responsibility for monitoring the patrons and ensuring no over-consumption is occurring.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Signage will be displayed stating that intoxicated persons and minors will not be served. Staff will be trained to follow the sale and supply of alcohol act 2012 and prohibit the sale of alcohol to intoxicated person or minors.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations and locations)

A free to use self serving water station will be available on site.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Staff training and sign-off sheets indicating the staffs understanding of the rules surrounding the act will be in place, and

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

No considerable noise levels will be generated by the business. If there was an instance of patrons being overly noisy either the owners or the manager would be tasked with settling the situation.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

As alcohol is not the primary offering at the business we do not foresee any issues of nuisance and vandalism. If there is any, again either the cafe manager or the owner would tend to the issue. Vandalism will be removed or covered where appropriate.



i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

None in the direct vicinity and no, the premises does not sell alcohol as a primary means of business, and will not permit excessive consumption of alcohol on site.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Beach, swimming and family activities. As we do not permit consumption outside of the licenced area, this should not impact the publics ability to enjoy the area and facilities.

- 1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

## 11. Payment

You will be issued an invoice at your lodgement meeting when you file your application. Payment of Fees MUST be made immediately on receiving the invoice.

If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. Timelines will be longer if there are agency oppositions or missing information on your application.
