b. What steps does the applicant propose to take to provide assistance with or information about alternative forms of transport from the club, for staff and patrons?

Staff training is provided to ensure they can assist patrons with safe transport options. Information about alternative transport, including local taxi company contact numbers, is clearly displayed on the premises. A taxi company number sign is placed on the wall, and trained staff can assist by calling a taxi or rideshare service upon customer request

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Standard signage promoting responsible drinking is displayed on the premises. A dedicated Host Responsibility card will also be displayed in a prominent location. The responsible consumption of liquor will be actively promoted at all times.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Alcohol will never be sold or supplied to minors. Staff are trained and will request valid identification from anyone who appears to be under 18 years of age. For intoxicated persons, trained staff will offer free water or light snacks and may suggest non-alcoholic alternative drinks. If an intoxicated person becomes disruptive or causes trouble on the premises, that person will be refused service and asked to leave safely.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations and locations)

Bottles of drinking water and glasses are provided free of charge to all patrons as soon as they are seated. Additional water is available at any time upon request from the bar.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Training is provided to ensure all staff are aware of the age of customers and their legal responsibilities. Staff are instructed to request identification from anyone who appears to be under 25 years of age, in accordance with the Host Responsibility Policy. Staff are also trained to monitor the intoxication level of customers, to offer free water, low-alcohol or non-alcoholic alternatives, and to encourage the consumption of food. These me asures are designed to promote responsible service of alcohol and ensure full compliance with the law.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The premises operate as a buffet & Bar, providing ambient background music only. We strictly adhere to the operating hours permitted under our licence. Staff are trained to monitor and manage noise levels to ensure they remain within acceptable limits and do not cause disturbance to neighbouring properties.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

The applicant will ensure that the Host Responsibility Policy is strictly followed. Staff are trained to monitor the intoxication levels of patrons and to arrange safe transport if required. The premises are fully lit outside to deter anti-social behaviour, and an alarm system is activated after hours to ensure security and prevent vandalism.



- i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)
 - Nearby licensed premises include many bar and restaurants and cafés. As our premises operate mainly as a restaurant, alcohol will only be served with meals. Therefore, granting this licence will not increase alcohol-related problems. Staff are RSA trained and all responsible service practices will be followed.
- j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

The land surrounding the proposed premises is primarily used for commercial and retail purposes, with some residential properties in the wider ar ea. The premises operate as a buffet and bar focusing on dining and food service. The granting of this licence will not impact or change neighbouring land use. The business will operate in a responsible and community-friendly manner, complying with all regulations regarding noise, litter, and patron behaviour. Therefore, the licence will have no adverse effect on the existing use or character of the surrounding area.

- 1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - · Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the
 applicant must ensure that notice of this application is attached in a conspicuous place on or adjacent to the site to which this
 application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

11. Payment

You will be issued an invoice at your lodgement meeting when you file your application. Payment of Fees MUST be made immediately on receiving the invoice.

If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

14. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application. More information about statutory timelines can be found at ccc.govt.nz/alcohol
