Alcohol is served with food generally, and staff always suggest food as first choice.

Persons who are either intoxicated, or appear so, will not be served. Those who are (or appear to be) 25 years old or below will be asked for ID before serving.

All tables are provided with carafes of water and sufficient glasses as soon as patrons are seated.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

An experienced Duty Manager is present at all times. Staff are trained in food & other duties specific to The Nook - and this includes host responsibility.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The Nook is a small Thai restaurant which generates very little noise. Unruly behaviour is not tolerated and noisy patrons would be ejected.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

As a restaurant in the theatre area of the city centre, our patrons comprise well behaved people who have a good record of behaviour.

New Regent street has a number of restaurants and bars selling alcohol. The renewal of the licence will have no impact on the area.

As above, New Regent Street is primarily an area of restaurants and bars serving locals and tourists. The restaurants fits perfectly.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

Please note, your full application, including name and contact details will be used by Council staff to assess and provided to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council’s Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee’s decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee’s decision on it. This information (which includes the application and all attachments) is made available to the Council’s Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.
