ENSURE THAT STAFF ARE TRAINED TO ASK FOR AND ONLY ACCEPT VALID ID, AND HAVE THE TOOLS AVAILABLE TO IDENTIFY IF PEOPLE ARE OVER 18 OR SHOWING SIGNS OF INTOXICATION. STAFF ARE ALSO TRAINED TO BE ABLE TO EFFECTIVELY SLOW OR STOP SERVICE AS REQURED.

IT IS AVAILABLE THROUGH LARGE BOTTLES OF WATER ON THE BAR, OR ON REQUEST AT THE BAR. BOTTLES AND GLASSES ARE ALSO STRATEGICALLY PLACED ON TABLES FOR LARGE GROUPS / THROUGHOUT THE BAR ON BUSY NIGHTS

STAFF ARE TRAINED TO UNDERSTAND THE VENUES HOST RESPONSIBILITY POLICY AND THE CONDITIONS OF OUR LICENSE. OUR QUALIFIED DUTY MANAGERS ENSURE THEY CREATE AN ENVIRONMENT WHERE STAFF ARE SUPPORTED TO CREATE A SAFE ENVIRONMENT FOR ALL

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

CURRENT NOISE LEVELS ARE LOW AS SPEAKERS ARE ALL INDOORS AND FACE INWARDS. THE PLANNED OUTDOOR AREA IS SMALL AND WE ARE TYPICALLY ONLY OPEN TO 9AM (WITH OUR LICENSE GOING UNTIL 11PM FOR OCCASSIONAL EVENTS). THE IMMEDIATE AREA IS ALL COMMERCIAL PROPERTIES.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

CURRENT LEVELS ARE VERY LOW, WITH NO INCIDENTS SINCE OUR OPENING. WE INTEND TO CONTINUE CREATING A SAFE AND POSTIVE ATMOSPHERE FOR ALL.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

THE SYDENHAM UNDERPASS AND BASE PIZZA ARE IN THE VICINITY. THIS APPLICATION WON'T IMPACT ALCOHOL RELATED INCIDENTS AS IT JUST ADDS A SMALL OUTDOOR AREA FOR PATRONS TO ENJOY, AND DOES NOT CHANGE THE NATURE OF OUR OPERATIONS

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

THE LAND NEAR THE PREMISES IS USED FOR COMMERCIAL AND INDUSTRIAL PURPOSES. WE ARE CONFIDENT THAT THESE BUSINESSES WILL NOT BE IMPACTED BY THE CHANGE TO ADD A SMALL OUTDOOR AREA TO OUR VENUE.

- Any other information you wish to include to support your application, e.g. business plan, promotional materials etc
 - **Bottle Stores 32(1)(b):** To assist with confirmation of percentage annual income expected from alcohol you may wish to complete a Statement of Annual Sales Revenue if applicable. Template statement available here ccc.govt.nz/consents-and-licences/off-licences/off-licence

Clubs

- 1. Provide an updated copy of Club Charter and membership rules (including details of any Affiliated memberships)
- 2. A list of names of clubs with which the club has reciprocal visiting rights for members; and
- 3. A Club Alcohol Management Plan and Club Alcohol Policy (desirable)

Notes:

- The Agencies may request to inspect a copy of your staff training plan/manuals.
- Tenure (Q7e) Additional information and/or signed documents may be requested in some instances to confirm tenure.
- Please remember to complete a separate Notice of Duty Manager Appointment or Change form for any new Duty Manager appointments or termination of duty managers and provide a copy to both the Alcohol Licensing Team and the Police, as detailed on the form cc.govt.nz/consents-and-licences/business-licences-and-consents/alcohol/managers-certificate/notification-of-management-change

11. Payment

You will be issued an invoice at your lodgement meeting when you file your application. Payment of Fee MUST be made immediately on receiving the invoice.

Accepted methods of payment are: CASH - EFTPOS - INTERNET BANKING

Note: All application fees are for processing of an application and are non-refundable, they must be paid when you apply. We can only process your application once we have both the Proof of Payment of fees AND the required paperwork (application form and required documents).

Important to note - Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

- 1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - · Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).
