We have adequate signage advising all patrons that we are able to call them a taxi instead of driving. This can be arranged with the Food & Beverage team or the Front Office team who are available 24 hours a day. Any guests Valet parking, will be denied their vehicle if intoxicated. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol? Our team are empowered to refuse service in the event of a patron presenting as intoxicated. Consumption of alcohol is monitored by staff and Duty manager on premises at all times. Anyone not complying will be offered water and food or asked to leave the premises. d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed? Only official forms of Identificatin are accept to prove the patron meets the age requirements to purchase alcohol. Team are aware and use the SCAB framework to identify anyone who may be intoxicated. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations) We have a water station located at the end of our bar, which is constantly monitored and topped up. Readily available drinking water is available on request from the bar 24 hours a day. f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law? Full training is provided to all team that are involved in the sale and supply of alcohol. Conducted when they are employed and monitored with any correction action should it be necessary. g. What are the current and possible future noise levels and how does the applicant intend to mitigate them? Current noise levels are low as alcohol can only be consumed inside the premises. Any patrons leaving the hotel are monitored by staff if noise levels are excessive. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them? Extremely low levels of this. Continued application of the SCAB framework to ensure that patrons do not become intoxicated. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain) OGB Bar next door to the hotel, we feel unlikely given 7 years of co-habitation in close proximity that this will cause any issues. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?
