Water station is set up alongside the bar area with jugs of water and lots of glasses to ensure free available at all times

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

We have a full induction process to ensure new team members are trained to identify minors, intoxicated behaviours, how to manage and slow service down, how to ascertain & check club membership before service of alcohol.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

As our venue is alongside residential housing, noise levels are kept low to ensure no disturbance to neighbours and reduced at 10pm, keep patrons inside the venue and encourage them to leave the carpark immediately after service with transport arranged at end of the night.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We border a CCC park so working with CCC on CPTED report findings to enhance area, prevent nuisance vandalism. The building has been a target for graffiti but this is not directly associated to the bar operation. We operate the bar as good community neighbours.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Closest venue is SouthPaw Brewery in the New Brighton Mall. Closest bottle store on Hawke Street.

Suburban housing and CCC Reserve Rawhiti Domain are next to our Club building. No changes happening.
