Recognising that tastings can be a social event and not necessarily everyones' favourite drink, we will also offer a small selection of drink styles that we do not make ourselves, such as beer and wine.

b. What steps does the applicant propose to take to provide assistance with or information about alternative forms of transport from the club, for staff and patrons?

Information/assistance with buses (Lichfield St bus interchange is only a couple of minutes walk away). Tram stop 7 is less than 1 minute walk. We can provide assistance calling a taxi and advice for booking a rideshare (such as Uber). And of course directions for walking, as we are located very centrally in Christchurch.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

We will not be selling any cheap/low price point alcohol and actively promoting the idea of drink less/drink better, ie higher quality/higher price point.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Age/ID check if they look under 25. No sales to intoxicated people. Fully comply with our Host Responsibility Policy (attached).

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations and locations)

Free hot and cold water is available via the bar. Tasting 'flights' will also include a glass of water, and part of the tastings will demonstrate how the addition of water can actually open up the flavours of the drink.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

LCQ and Duty managers qualifications in conjunction with Host Responsibility Policy. Intoxication assessment guideline tool is visibly located to help aid with assessment.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Minimal - new build with 200mm thick conrete tiltslab walls for acoustic insulation of inside noise. Will be well below CCC permitted noise thresholds. Our outside space is very small and totally constrained within the developments internal 'Lichfield Courtyard', so noise will be minimal and well below that emitted from neigbouring hospitality venues and the new TE KAHA stadium, which is practically our neighbour.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We have installed our own private CCTV security camera system, which complements the developments communal system and provides a visible deterrant. Additonally our property is fitted with a security system (PIR and reed switches) with external lights and sirens which re-inforces the deterrant. In terms of alcohol sales, our OFF-LICENCE only allow sales until 9pm, pre-emptively matching the proposed LAP.



i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Jabba Grill and Bar (Steak restaurant), and their offshoot Tiger Baby (bar and waiting lounge for Jabba) are in the 150 Lichfield Street development along with us and with A'mano Authentic Pasta and Cucina. Dux Central is also our immediate neighbour. Granting of an ON-LICENCE will not increase alcohol related problems in the area, as the development was designed and consented with hospitality in mind. Its a 'low risk' application as its primarily intended to allow us to charge for more comprehensive samples and a paid drink or two afterwards, rather than prolonged session drinking.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Surrounding land use includes a carpark building, the rest of the 150 Lichfield Street development (consented for hospitality use for all ground floor units), the Dux Central and the One NZ building (who's entrance is not near ours). The new Te Kaha Stadium (One NZ Stadium) is located barely 100m away from our location. The CCC has recently spent over \$5 million on upgrades to our portion of Lichfield St to accomodate the pedestrian traffic to and from the new stadium, so that it can be a safe and vibrant area.
