Signage clearly displayed. Free water available at all times. All staff are fully trained in their host responsibilities around the service of alcohol.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Security will be present on busy nights and event days on the door to prevent entry to minors/intoxicated persons. Staff ID check anyone who looks under the age of 25. Signage clearly displayed outlining responsibilities.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Free water will be available at all times from service points at both ends of the restaurant. Free water will be served to the tables in the restaurant and functions.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

There will be at least one Duty Manager present at all times.

Staff are fully trained in their responsibilities around the responsible service of alcohol. All staff required to undertake servewise online training.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

All bands/entertainment is finished by 12am, noise levels are kept at a level so as not to disturb neighbours.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Low current level of nuisance and vandalism. Security are on for higher risk events. Staff ensure surrounding areas are free from rubbish/vandalism at the conclusion of each day/event. Regular checks of surrounding areas are carried out by staff/security.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Mitchelli's Cafe, Penny Black victorian tea rooms. There will be no increase as this is a renewal to a currnet licence and does not increase the levels of alcohol available in the area.

Boutique shopping mall. Residential. Industrial. there will be no further impact as this is a renewal.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application. More information about statutory timelines can be found at ccc.govt.nz/alcohol
