Provide low-alcohol and non-alcoholic options: Promote safe transport options: We always encourage people to have a designated driver or provide transport option. We ensure that our staff are always supported in refusing service to Prevent intoxication. We provide training to staff member to assess intoxication. We are quality dining restaurant and has lot of food options for guests. We always promote responsible drinking

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Age verification for any guests - If we believe our guests are under the age of 25, we will ask for identification i.e. acceptable forms of proof of age. Guest are not allowed to become intoxicated and no serving to intoxicated people and will be asked to leave the premises and encouraged to take advantage of safe transport options. Staff are trained and will politely intervene to prevent them from becoming a danger or nuisance.

We will have free water available on the bar bench-top for customers.

Free water will be available all the time. We also serve / provide water on the tables as well.

Two bottle of water are supplied free of charge to the guests staying in the hotel room

Staff Training on identifying and understanding requirements to ensure compliance with alcohol laws. Training on proactively dealing with intoxicated persons. Basic interventions Training will be provided to understand of basic interventions techniques to help manage the sale and supply of alcohol such as offering non-alcoholic drink, slow down the service, low alcoholic offering and stopping the sale and supply. FREE LCQ *

Low Noise Level, as music is only provided at low volume level so people can enjoy their food and drinks in the restaurant.

During Event and Function, we also ensure that the noise level stay at reasonably low level as we have guest staying in the hotel as well.

No there are no current and possible future levels of nuisance and vandalism. Customers visit our business to enjoy nice food and drink quietly.

No, it will not contribute to an increase in alcohol related problems because we offer dining experience along with drinks Our focus to to look after our hotel guest traveling for business and tourism. Our guest are not allowed to become intoxicated and no selling to intoxicated people - Our staff always have guests safety and enjoyment in mind. We want to see our guests regularly and also assist them to get home safely.
