Question 8.

Changes sought to the present conditions of the licence.

- a) <u>Correction</u> to the licenced premises. The site plan on the next page is from the 2022 renewal detailing the licensed area within the blue boundary line, the correction is on page following
- b) <u>Reduce</u> the Supervised Area in the Essex Bar.
- c) <u>Addition</u> of the Bar in the ground floor Westminster Room refer to the plan attached showing the Supervised Area in front of the bar.

<u>Explanation</u>. The ground floor Westminster Room has been used as a conference, function and meeting space and occasionally, as part of the dining area for the upstairs Tudors Restaurant when it has been unable to accommodate the number of guests wanting to use the restaurant. Although there is a kitchen by the Westminster Room, it is seldom used as it is more economical to prepare meals in the large upstairs kitchen and bring them downstairs to guests. The food served and menus offered will, therefore, be the same as those offered at the upstairs Tudors Restaurant.

When conferences, functions and meetings are held in the Westminster Room, the upstairs kitchen is usually used for food catering purposes. It is proposed to use the small bar in the Westminster Room as and when required for functions and conferences and to supply alcohol to guests dining in that room as part of their meal. The range of alcoholic drinks will be similar to what is offered at the upstairs Essex Bar, together with the same range of non-alcoholic drinks. Water will always be available.

The hotel wishes to promote the use of the Westminster Room for functions and conferences and be able to serve alcohol from the bar in that room.

There would be no change to current licensed hours.

d) <u>Mini Bars.</u> It is proposed to add mini bars to all guest accommodation rooms – one small fridge to each room.

<u>Explanation</u>. Refer to the accompanying details for the range of alcoholic and nonalcoholic drinks and snacks that will be available from each mini bar and the servicing of the mini bars by the hotel staff daily. It will be seen that a small selection of alcoholic drinks will be available from each mini bar.

The provisions of section 46(3) of the Act will apply to the mini bars.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

- 1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.
