Free use of phone to call taxi. Shuttle service 4 days a week. Bus stops right out front of the Club.

Having food service available at all times that alcohol is being sold. Having a current host responsibility policy that is displayed to the public in the main entry and states how we will manage intoxication and minors, information on the provision of food, low and non-alcoholic drinks.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Ensuring staff are properly trained and are reminded at all meetings of the law in regards to intoxication, minors and especially the specific laws regarding club members, guests, affiliated members and their guests. Copies of the intoxication assessment tool are at every till in every bar.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

There is a free water tap with clean glasses at every bar for use by patrons.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

By adhering to our Host Responsibility Policy. By ensuring staff are trained and the training is documented. By ensuring we have adequate staff under the direction of a properly trained and certified Duty Manager. Licensing Law is included in every staff meeting.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The design of the building is such that the main foyer acts as an air lock and ensures that noise from the three bar areas does not escape the building. There are no changes proposed to the premises or operations that could increase noise.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Current levels of nuisance and vandalism are basically non-existent. As we are a club our members show more care for their club and neighbours than does the average patron at a pub or other bar and we take a much harder stance on inappropriate behaviour to ensure it stays that way.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The closest venue is the Tavern Harewood approx 1.8km away. Renewing this licence will in no way contribute to an increase in alcohol related problems.

Residential housing to the south and east. Sporting fields to the north and west. School to the west. Renewal will not result in any change to the neighbouring land use in any way.

2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

### 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
