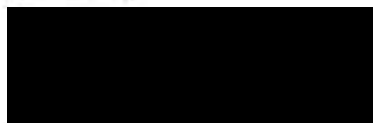

- Correct signage is up informing patrons of alcohol law.
- Free water available for patrons. Promote food & low alc beverages.
- Taxi can be called for patrons.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

- Staff are trained on their behaviour (SCAB) to monitor alcohol behaviour. Signages indicating "No service to minors, NO ID, No service, are posted throughout the venue."

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Water is freely available at both bars (Patio & Dining) & available on table when dining in.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All staff are trained for safe supply of alcohol at the time of induction. Ongoing training is done regularly & debriefings before events.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Noise / music / entertainment are kept at a level to be heard inside the premises only. Decibels are monitored through the event. Organizers are made aware to not disturb neighbours.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Noise levels are maintained to be heard inside the venue only. Security is robust & manages to keep vandalism at bay & involves the police if required.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

St. Asaph Street has other bars & restaurants but not too close to the venue. There is a food court & a cafe in near proximity which are mostly dining places.

There are offices opposite & a cafe next door to the venue both close by 4-5pm. New build coming, another construction.

This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
