

- (f) What steps does the applicant propose to take to provide help with and information about transport options from the premises?
  - Safe transport options are promoted verbally as customers leave and signs promoting safe transport options are prominently displayed.
- (g) What steps are proposed to be taken to prevent the sale and supply of alcohol to prohibited people?
  - All staff are trained to observe and identify minors. If a customer appears to be under 25, alcohol is not served unless they are able to provide accepted identification which proves they are 18 or over. Intoxicated persons are not let into the premises.
- (h) What other steps does the applicant propose to promote the responsible consumption of alcohol?
  - Meals are served at all times. A large range of non-alcoholic beverages and free tap water are available at all times. Alcohol sales are monitored to prevent excessive drinking and, if necessary, service of alcohol is stopped.
- (i) What other systems (including training) and staff are in place (or will be in place) for compliance with the Act?
  - All managers receive training from accredited providers on their responsibilities under the Act and in host responsibility. Managers then in turn train restaurant staff.
