Signage will be posted to promote taxi services that are available.

Employees will be available to call taxi services for all customers.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Restricting consumption to not be serving any intoxicated patrons. Ensuring non-alcohol and low alcohol beverages are available at all times. Making food available at all times that alcohol is available for sale.

Not promoting an excessive drinking culture at the premise.

Ensuring a duty manager with a Managers Certificate is rostered at all times. NO CLIMBING AFTER CONSUMPTION OF ANY ALCOHOL.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

The Alcohol Management Plan and Host Responsibility Policy will be adhered to at all times (included in staff training and staff compliance will be monitored).

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations and locations)

A filtered cold water dispenser will be installed within close proximity to the bar with signage stating its availability posted at the bar.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All staff will be trained on the following (content): Alcohol Management Plan, Host Responsibility Policy, Any conditions received on the Liquor Licence, The Intoxication Assessment Tool. Training schedule (duration & frequency): Training will be provided to each employee with understanding proven with written quiz. On induction (1 hour training, or as required until knowledge demonstrated in quiz) At every 6 months of employment (1 hour training with written quiz different to induction). A training record sheet will document proof of training.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

This business doesn't play loud music and also isn't set up as a loud environment. Ambient noise from patrons and relaxed music is subdued and not loud. Close of business is 10pm.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Nuisance and vandalism hasn't existed in Boulder Co Auckland or Hamilton. If it did exist, the patron would be asked to stop what they are doing and would be asked to leave the premise if behaviour continued. If there was a risk of further behavoiural issues once the patron had exited the business, the police would be informed.



i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The premises are located in a retail area without other licensed premises in nearby proximity. The granting of this licence will not contribute to an increase in alcohol related problems in the area due to the patrons of Boulder Co being health and fitness conscious resulting in low levels of alcohol consumption.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Land near the proposed premises zoned commercial and is being used for retail (Early Settler Furniture, McKensie and Willis Furniture, Java Furniture). The granting of a license for our premises will not impact on changing neighbouring land use.

 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

You will be issued an invoice at your lodgement meeting when you file your application. Payment of Fees MUST be made immediately on receiving the invoice.

14. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
