

Regular promotions on food items and the inclusion of food in beverage promotional 'packages' eg. beer and a burger for \$X. Promotion of soft drinks & non-alcoholic beverages. Staff well-trained to assist in guiding customers toward responsible options.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Duty Manager on site at all times. All staff regularly trained on relevant legal requirements and how to check IDs. ID required for anyone that looks under 25. Signage displayed at appropriate locations incl. DOB quick reference charts for staff.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Plumbed water stations both inside and on the deck. Water also available at the bar. Signage within venue directing patrons to free water station.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Regular staff trainings with all staff covering: Sale & Supply of Liquor Act, Host Responsibility Policy, Role of the Duty Manager etc. All senior staff are given the opportunity to complete LCQ training.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Low - the premises is located within the Christchurch Adventure Park village which is removed from residential areas. The music systems within the cafe are not capable of generating enough volume that they would be heard outside of the village. We are not aware of any past or present issues in this regard.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Low - the premise primarily trades during the day to support the activities within the park. Outside of park trading hours the cafe space can be used for events, and security is on site when required. We are not aware of any past or present issues in this regard.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There are no other licensed premises within the vicinity due to the nature of the Adventure Park. The cafe has been licensed since the park opened in 2016 and we are not familiar with any alcohol related problems in the area as a result of this licence.
