Members and their guests who are visibly intoxicated will not be served alcohol, will be asked to leave the premises and will be encouraged to take advantage of safe transport options.

It is against the law to serve alcohol to minors. If we are in doubt about your age, we will ask for identification. Acceptable forms of proof of age

Water is Bar service, and plumbed water station at main Bar. Also have water dispensing units at the bars, water bottles (jugs) available on request.

We maintain a training and management policy to give our bar staff the skills and support they need to do their job responsibly.

This is primarily through our affiliation to Clubs NZ.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

We have no issues with noise levels, any bands we have playing are well within the premises and can't be heard from the outside of the building.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We have installed a number of security cameras which are monitored, when hosting 21st parties we have security guards onsite, staff are constantly patrolling the premises during the times we are open

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The Birdwood and Protocol are approximately 1km from us. Armadillo's, Moon under water are approximately 2kms from us. There will be no increase in alcohol related problems in the area as there is no increase in licenced premises.


