

All the staff has access to use the company uber account and free phone taxi numbers are located by the front counter. Staff are also happy to call taxi on behalf of patrons

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

We closely monitor our patrons and ensure there are water jugs always available and taken out to the tables when there are consumption of alcohol. Along with upscale of entrees and food.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

All staff are constantly reminded to ID large groups. Anyone that looks under the age of 30 and 25 years old with no ID will not be served or allowed to consume alcohol on premise. Intoxicated persons will be refused entry.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Jugs of water are situated on each table, constantly replaced when empty and refilled so it is readily available

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

This is covered in staff induction. Duty manager also reminds and re trains. Allocated handbook on front counter for staff. Signage from ALAC. Responsible host policies.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Low - potentially some patrons leaving and saying goodbye. Music and sound are kept at moderate levels. Doors and windows remain closed during operations. Regular checks are conducted by staff.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

No significant incidents of vandalism or nuisance associated with our premises. Our restaurant table service and seated dining, helps limit opportunities for disruptive behaviour. Staff are trained to monitor customer conduct and de-escalate situations discreetly and professionally. Clear signage and security cameras installed.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There are a number of other licensed premises including flux, chi chi kitchen, soul pocha and little high eatery. No, I believe it won't increase any alcohol related problems in the area - most of the time alcohol is served to patrons along with food, under supervision of trained staff who comply with the act and as a restaurant we don't host late night parties - low risk.

Combination of commercial, hospitality, creative, and small business activities. The area is a vibrant mixed-use precinct that encourages collaboration between food and beverage venues, offices, retail shops, galleries, and studio spaces. We believe renewing our license wont negatively impact the premises but instead complement the area.
