The winery operates a courtesy vehicle locally for staff and patrons. We also recommend and work in with the local taxi service

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Ensuring staff are trained in the responsible service and sale of alcohol and can recognise levels of intoxicification. Adequate host responsibility signage, Provide at all times during opening hours a range of substantial snacks, water and no and low alcohol beverages.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Ensure staff are aware and understand our host responsibility policy including the process for removing or cutting service to intoxicated persons. Ensuring staff check ID of all persons suspected of being under the age of 25 years.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Water is given to guests on arrival and topped up regularly during their visit and consumption encouraged.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All staff trained in host responsibility and are aware of the business expectations, they are also kept up to date with any changes, all patrons suspected of being under 25 years of age are asked to prove their age identification, if they are unable to provide this they will not be served.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

As per the attached RMA all doors and windows to be closed by 10pm and no outdoor speakers or amplified music after 10pm

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

To date we have had no problems with nuisance or vandalism. We also have a caretaker/driver living on the premises to keep things safe at night and he also operates the courtesy van during opening hours.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

No licenced premises within a 1km radius. We do not see this licence contributing to alcohol related problems in the area

The land nearby is a working vineyard and part of the business, no change is proposed to current land use.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

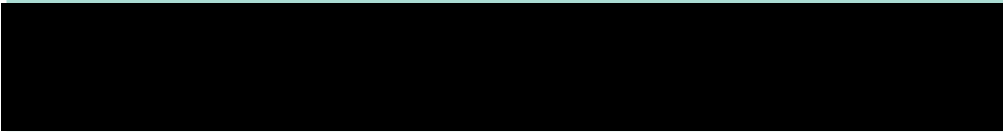

This information (which includes the application and all attachments) is made available to the Council’s Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.
