We will display taxi companies and dial a driver cards and offer at any/all stages to call or arrange a dial a driver or taxi. Bus stop is located 100M from the salon and timetables are available to everyone via our two salon IPADS

we give complimentary crisps or popcorn with each drink served. also complimentary water and refill throughout hair service in addition to offering tea and coffee. Food menus for restaurants are offered as are snacks menu displayed around the salon. alcohol is an "add on offering" to hair.

full signage in our serving area explaining we do not allow intoxication and we openly offer food and non alcoholic beverages. We have systems that ensure identification is being checked and our staff are trained to recognise intoxication in customers.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Drinking water is available in serving area via water filter. this is offered at all times in addition to tea and coffee throughout the hair service.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Full training procedures for new staff including to prompt age checks. we have two CCTV cameras. we have monthly staff meetings which covers general compliance. we have adequate staff, management team and additional staff rostered for peak times.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

we have not had any past, current nor do we anticipate any future issues in relation to noise.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We have two CCTV cameras, one located at the front entrance one at the rear, this in addition to our security protocols with SUB 5 physical checks at random times every night and Code 9 whom monitor our alarm and glass break sensor 24 hours a day.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

We have JDV and aikmans down the street. We do not see that by granting a renewal will contribute to an increase in alcohol related problems as our main business is a hairsalon as its core focus, not a bar.

We are located on Aikmans road in Merivale, this is a vibrant commercial area and our presence will not have an impact of the neighbouring land as alcohol is not our core business, hairdressing services are.
