We have signs regarding safe driving options, people are welcome to use the club telephone to call a taxi, and many of our members use Uber when necessary.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Free water will be available at all times. Catered food may be purchased. Chips and nuts are available over the bar; frozen meals are kept available on request. We have signs regarding intoxication around the bar, and inside the bar to assist bar staff with assessing club members' condition.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

All people who are not known as club members are asked who they affiliated with; anyone who is not involved with the club or reciprocating club is asked to leave; members who appear to be close to the legal age limit are asked for proof of their age. Bar staff regularly use the 'SCAB' intoxication assessment tool to monitor club members' condition and they not served if they do not meet the requirements.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Water jugs are kept filled with empty glasses nearby and available at the bar area and next to the kitchen serving hatch.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Our bar manager will provide training to our limited volunteer bar staff about applying 'SCAB' test and the club's host responsibility policy and will ensure that all activities are maintained within our legal responsibilities.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The club has a stereo system inside the lounge, which is kept at a respectable level - most other noise associated with the club relates to sporting activities (spectator cheering, applause, etc). To our knowledge, there have been no complaints about noise during our last licensed period.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Any disorderly conduct or nuisance will result in the club member or guest being told to leave and they will be liable for the club's disciplinary procedures via the club Discipline Sub-committee. Occasional vandalism to our building has not been carried out by club members but by unknown delinquents, and is cleaned up as soon as possible after discovery. We anticipate no change in levels of nuisance or vandalism.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Bowls Papanui on Condell Avenue is about 300m away. Its bar is open 8am-10pm Sunday-Thursday and 8am - 12am Friday-Saturday for its members and affiliates. We do not believe our licence will increase alcohol-related problems in the area as patrons are connected to the club and subject to its disciplinary procedures

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Edgar Macintosh Park is the home ground of our cricket club, and is routinely used for cricket on summer Saturdays for matches, as well as many midweek evenings for training and some Sundays for social events. We have had a licence for many years and do not anticipate any new impacts on the community and neighbouring land use.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application. More information about statutory timelines can be found at ccc.govt.nz/alcohol
