The Hotel and its staff will comply with the objective of the Sale and Supply of Liquor Act and the said staff will be trained to understand and appreciate these objectives to ensure that all of our guests are safe and secure. (see sheet attached for full answer)

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

We will have comprehensive manuals and training materials that will be issued to staff members and used in regular training sessions to ensure that all employees are fully conversant with the Act and its requirements and our responsibilities to uphold them.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

There are several free drinking water stations with jugs and glasses available throughout the ground floor area including the lobby, bar and dining room. Table service water is also available at all times

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

Please see attached sheet for all full answers. We are now also signed up to HNZ and are using Tyspy for all staff training including all liquor licence related training.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

A Senior Manager/Duty Manager will be on duty at all times and it will be part of their responsibility to ensure that no rowdy behaviour or inappropriate levels of noise will be allowed or tolerated. This ruling will be strictly observed at all times.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

There are to the best of our knowledge no current incidence or vandalism but it will be our intention to engage a regular security check service from a reputable security company throughout the evening and during the night time.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Christchurch Casino, The Town Hall, Crowne Plaza, Whiskey Galore. All of which we believe to be reputable and well managed and we are not aware of any alcohol related problems in the area.

The majority of land in the vicinity is predominantly used for commercial use including licenced premises and it is not envisioned that any impact will result to change the use of any neighbouring land by the granting of a licence to our premises.

Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it.
