

	We are currently renovating the downstairs area of the clubhouse to include a cafe and bar area that is more user friendly and accessible for our members and visitors to use. We would like to be able to serve alcohol in this area. Additionally - there is a chiller on our ground floor that has not been indicated in previous license renewals. This chiller has been in the same location for many years (at least over 10-20+ years).

JUGS OF WATER WILL BE AVAILABLE FOR SELF SERVICE AT THE END OF THE BAR.

 BAR MANAGER WILL BE ON SITE OR WITHIN 30 MINUTES OF THE PREMISES. ALL STAFF ARE REFRESHED ON THE REQUIREMENTS FOR THE SALE AND SUPPLY OF ALCOHOL USING THE TRAINING DOCUMENT SUPPLIED BY PINNACLE HOSPITALITY.
- g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The upstairs lounge is utilised for club prizegiving's, club fundraising events and for members and authorised visitors to enjoy a drink and food after their game of golf. Clubhouse is set in the middle of 53ha semi-rural golf course with any noise unable to be heard by neighbours.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

The first floor lounge is only utilised for short periods of time for prizegiving's, fundraising events and players enjoyment of a quiet drink and food after their game. We do not foresee any nuisance or vandalism as a result of these low risk activities. The same would apply if we were granted a variation to our current licence for the downstairs bar area.

i) What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Yaldhurst Tavern and Islington Tavern are close by (1-2km). Renewal of this license will not impact or increase any alcohol related problems in this area. Existing license has been in place for a number of years and if our variation is granted, this would not change.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

Fulton Hogan, Ruapuna Raceway, Waterloo Business Park and an onion farm currently border the golf course property. The clubhouse is located in the middle of the 53ha course, and the granting of this license will not impact on neighbouring land use.

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

 will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
- 2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
- 3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

Renewal with Variations will not be accepted without an Inspector Verification being completed.					
14. Processing Timelines:					
Premises applications should be made well before your licence is required. On average about 5-6 weeks is required for a standard application to allow for public notification, processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are public objections or agency oppositions or missing information on your application.
