We have free water at all times for the intoxicated persons. It is in the soft drink fridge.

As an OFF licence this is not applicable. But if such thing occur outside, we ask them to leave the area.

Graffiti is an ongoing problem. We try to take it / paint over it. Any litter outside the store and nearby we clear it on a daily basis.

Yanki Bourbon - 600m, Super Liquor Lincoln - 1 km away. No. People can ~~access~~ get alcohol as there are other stores around, but we have a strong policy toward intoxicated persons and minors.

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. What appropriate systems , staffs, and training is in place or will be put in place to ensure compliance with the law.

1. There is an in house policies and procedures to ensure that all employees at every level are well aware of the requirements that are in place to guarantee compliance with the various legal responsibilities in the business specially relating to the Minor and intoxicated people. 'No ID No service policy' and ' No intoxicated persons permitted'.
2. The in house training programme will include the new changes of DLC to make sure all staffs get trained/ informed. The copies of the new amendment will be handed out to the staffs.
4. We have an Incident book in place to record any incidents during the business hours in and out side the premises - the incident, time incurred and people involved and the outcome/solution reached.
5. Extra staff during busy hours and nights to ensure customer and staff security. First aid kit available for any unseen incident.

Noise level

As an off licensed area we have not really experienced the above issue in past the years of operation from here. If any such incidents occur we would take every endeavor to stop and bring it under control. Trading hours for the store is :

Sunday and Monday = 10am- 8Pm

Tuesday- Thursday = 10 am- 9pm

Friday and Saturday = 10.00am -10pm

Vandalism.

We have a house policy of clearing/picking up any empty cans or bottles (if any) around the store. We will still be doing the same to reduce such things. We have a security camera outside our shop to capture the pictures outside to reduce any kind of vandalism around the premises. The Graffiti is an ongoing issue for us like in the other part of the city

Nearby Licensed premises .

The nearest Off licensed is 'Yankee Bourbon Company' on 264 Ferry Road which 650 M is away. The other nearby licensed premise is super Liquor Linwood on 227 Linwood Ave which is 1.2 Km away. I do believe from the past years of operations from this premises that by granting of this licence would not help or contribute in increasing the alcohol related problems in the area. We operate responsibly within the liquor regulations. We serve the customer with respect and care and walk out with a smile on their face. But we had occasionally unhappy customers as we had to adhere to the alcohol act and policies to render the services in very responsible manner.

Nearby Land used for:

We are in a complex where other stores like packaging shop, Power steering repairs, Builders office and Bakery factory. The next building toward Ensors Road is St Johns OP shop, Madbutcher /Harvest Market and Couplands bakery. Opposite to our liquor is the card yard and the starting of the residential area.

I would strongly suggest that there will be no kind of negative effect by granting /renewing license to this premises as we always deliver a responsible service to the public adhering to the sale of liquor Act and its policies. As mentioned earlier I had hardly seen any negative incident or impact in and around our shop in the past years of trade. We always advocate 'responsible drinking for good health'. Our customers don't walk out of our door' intoxicated' or 'drunk', whereas they take away the product and have it at the comfort of their home.
