Staff will be able to provide directions to a bus stop located nearby.

They can also call taxis to pick up patrons from the Westfield upon request.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

We will provide and actively promote free water, as well as low-alcohol and non-alcoholic alternatives.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Our staff will be trained to ensure that the process of identifying minors is robust. As a restaurant, we will create an environment where intoxication is not tolerated. Security guards in the mall can assist us if intervention is needed.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Drinking water is freely available at all times within the shop. It will be openly accessible, and our staff can also provide it upon request.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

There will be a trained/certified manager on duty at all times to ensure that the law is properly complied with. If the manager is not present at the restaurant for any reason (e.g., an emergency), we will not sell or serve alcohol until the manager returns.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

We expect the noise level to be similar to that of other restaurants within the mall. We are very close to the food court and other food vendors, so we believe the noise level should be consistent with our surroundings.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Our managers will be trained on how to deescalate situations that may cause nuisance and/or vandalism. If a manager finds it difficult to handle a situation on their own, they will always have access to the mall security personnel, who will be present in the building during training hours.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There are no other premises in the vicinity that serve alcohol. The closest is Fox and Ferret in Riccarton; however, because there are bar areas across the street and we are a family restaurant next to the food court, the risk is considered relatively low.

The mall is family/children-friendly, and the proposed premises are surrounded by shops and other food vendors.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
