Free water will be available during all tastings and at anytime for all visitors. Responsible alcohol consumption signage will be displayed. Our products are premium craft products and our prices will be significantly higher than standard alcoholic beverages, the cost will be a deterrent to irresponsible consumption

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

We will ensure that all staff are conversant with the requirements of the Sale and Supply of Alcohol Act 2012 and trained in its application. Alcohol will not be sold to prohibited persons, including under age or intoxicated. All customers will be assessed for signs of intoxication using the SCAR criteria and refused service if intoxicated. Proof of age will be required for anyone who looks under the age of 25

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Free drinking water is available at all times at the front counter and in the tasting room.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All current operational staff hold Duty Manager's Certificates and understand the requirements of Sale and Supply of Alcohol Act 2012. Anyone else who may assist with the business from time to time will be fully briefed on the Act, compliance and our license requirements and restrictions.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The area is an industrial zone. Noise levels from a small off license are not expected to effect the existing noise levels in the area.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Nuisance and vandalism levels are not expected to be effected by the presence of a small off-license in the area. The distillery shop will be a destination for enthusiasts of craft spirits and is not expected to attract general retail liquor customers

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Benny's Barber and Renegade Brewery on Sandford and 5th Street restaurant on Durham St are the nearest licensed premises. We will only be selling premium priced, craft spirits for consumption off-premise so we don't expect any implications for alcohol related problems in the area.

The area nearby is used by general light industrial premises of many types with some small scale retail. The renewal of the license will not impact on the neighbouring land use.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
