promotions never centre around alcohol and never encourage rapid or excessive alcohol consumption. The front of house team engage with their customers to provide great service and also to more easily monitor them for signs of intoxication.

A comprehensive Host Responsibility policy is in place and supported by signage that states:

No alcohol will be served to Minors + No intoxicated persons will be served

Water is brought to tables in the restaurant, and self service from bar top, and in jugs at tables during functions

there is no live music. A stereo system is controlled by management. Noise is not an issue due to the style of business and clientele.

This is a 5 star hotel and as such the possibility of nuisance and vandalism is remote. The customers are travelers and business people visiting Christchurch.

Located in the inner city with serveral licensed restaurants and bars as neighbours. Purpose built hotel. The restaurant is open to the public with the front door facing the street. Team is trained to refuse service to anyone who appears intoxicated who are asked to leave or go to their room

Inner city that is enhanced by the Sudima Hotel which is run by experienced professionals. The Sudima brand is well known and has not had any problems since they opened in 2019.

1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

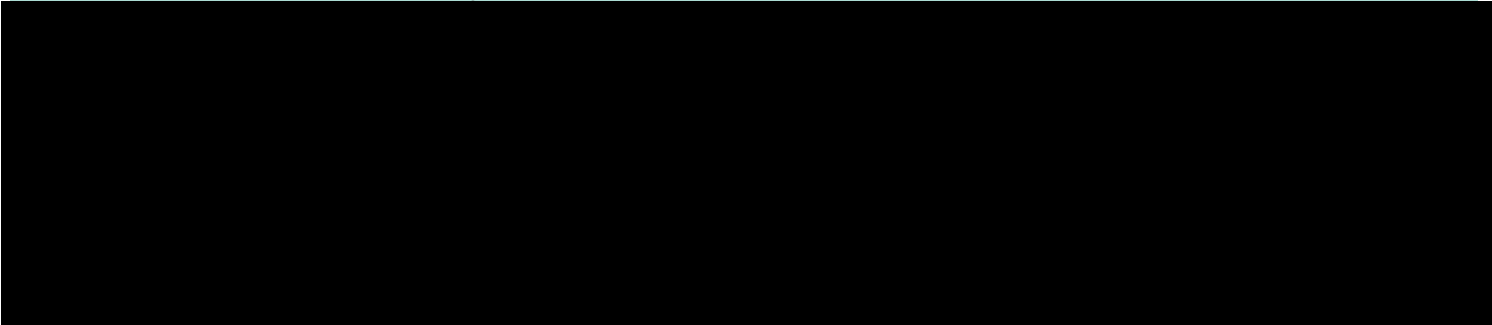
Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. Please note, your full application, including name and contact details will be used by Council staff to assess and provided to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.
