To promote responsible alcohol consumption through staff training, the provision of food and non-alcoholic alternatives, clear signage, safe service practices, active monitoring, and promoting safe transport options.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

To ensure compliance with the Act by requiring staff to check identification for age verification, refuse service to minors and intoxicated persons, provide regular staff training on legal obligations, and maintain active monitoring to prevent sales to any prohibited persons.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

A water station is located at the end of the bar which is easily accessible even when busy. This is a water tap for unlimited water and at least 3 trays of glasses to ensure there is always enough. Also water jugs if patrons wish to take water to their table

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

We will have trained and certified staff, robust age verification and refusal of service procedures, regular host responsibility training, clear operating policies, and active management oversight to ensure full compliance with the law.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

All outdoor speakers are turned off at 9pm.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

The current and potential levels of nuisance and vandalism are expected to be low, and we intend to mitigate them through proactive security measures, staff monitoring of patron behaviour, clear house policies, maintaining a tidy environment, and cooperating with local authorities and the community if any issues arise.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

There are a few other licensed premises in the vicinity; however, the granting of this licence is not expected to contribute to an increase in alcohol-related problems, as the applicant will operate under strict host responsibility policies, ensure compliance with all legal requirements, and actively manage the premises to minimise any potential harm.

This is a residential area, but due to the nature of the licensed premise, trading will not affect any neighbouring areas as it is not a 'late night' trading operation. More of a family friendly environment.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

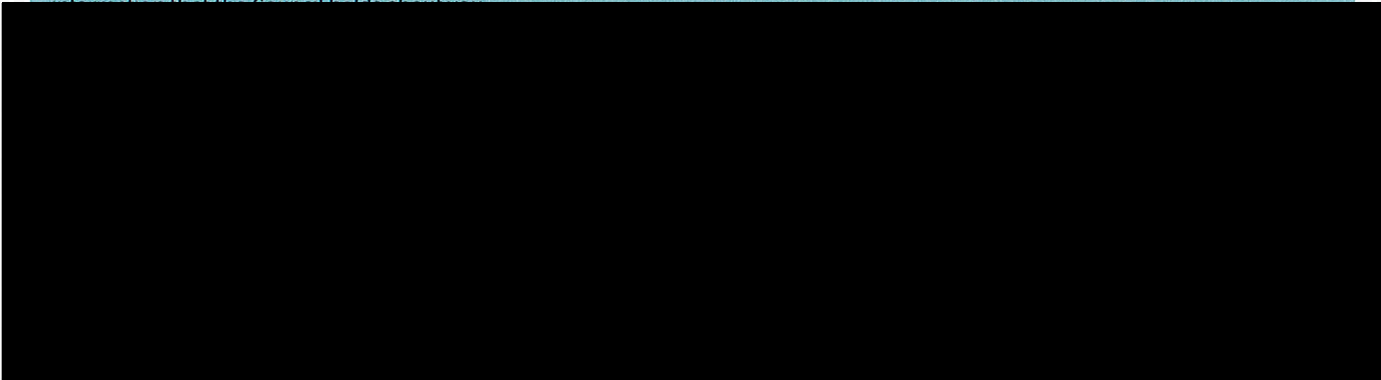
Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. Please note, your full application, including name and contact details will be used by Council staff to assess and provided to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.
