Through staff training, having the knowledge of local bus stops/routes and also holding contacts to taxi services. Calling these services for all customers.

Having the staff understand the sign of intoxication through staff training and knowledge of our host responsibility policy. Then promoting or more food plus and use of low/non-alcoholic drink substitutes.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Recognising sign of intoxication and checking ID on any person who may appear under the age of 25 years. Display appropriate signage, either slowly serve & make slowly sign of intoxication or even removing from premises.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Being a restaurant, every single person has a water poured for them and a full water bottle remains on the table also, which is consistently changed over.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

The staff are provided with a copy of the restaurant host responsibility policy as well as the job training in dealing with customers and service of alcohol. This is reinforced with monthly staff meetings.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Noise levels are easily contained by the premise being predominantly inside. Also the surrounding area is entirely industrial/commercial. Vandalism.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We are a food focused restaurant, which does not encourage excessive consumption of alcohol and feel our trade would not contribute to local nuisance or vandalism. We do however have a good security and camera system set up.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The area is very scarce of hospitality. Hello Sunday across the road holds a licence but trade mainly through the day. So being so isolated leads us to believe this licence would not indicate alcohol related issues in the area.

It's mainly industrial/commercial with the exception of the Columbus Mall. The renewal of this licence would have no major impact given that the nature of the business hasn't changed and no new hospitality businesses have been built in our area.

## 12. Important to note – Public notification of application

1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

#### Privacy Statement

Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.

### 14. Important to note — Renewal with Variation Lodgement and Invoicing

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

### 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
