Signs will be displayed promoting alternative transport. Reception staff undergo training and will ask guests if they wish to have transport arranged for them when they leave the premises. A phone is placed in every room with phone numbers for transport listed in the information material. Staff will offer guests the use of the phone at front desk if required.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

Staff are assigned tables when waiting in the restaurant and are trained to note the amount of alcohol a person is consuming. Water, tea, and coffee is offered as an alternative. Liquor promotions will not take place on the premises that would encourage excess consumption of alcohol. A host responsibility statement is displayed on the premises.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

Prohibited person signage is displayed at every bar and restaurant. Staff are trained to verify the age of a person appearing to be under the age of 25 years of age. Staff will refuse service to anyone that is suspected of being under 18 years of age (a minor). With regards to intoxication, signs are also displayed in the same vicinity as above. Staff are trained to assess customers using the SCAB system.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Jugs of water and clean drinking vessels are placed at any bar, within any lounge and placed on tables when customers are seated. Water will also be provided if requested.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

A host responsibility policy (attached) is part of staff training. Initial and ongoing training by the food and beverage manager at regular meetings will assist with any concerns staff may have. All F.O.H staff are made aware of the conditions of the on license displayed at the principal entrance. ServeWise training is suggested to be taken by all staff, in particular new staff.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Noise levels are kept to a minimum and if music is played, it will be low levels of background music. It is of great interest to the management staff and owners that guests have a peaceful visit as well as people living/working in the surrounding area. As Fables Christchurch is a luxury hotel under the Accor brand, there is an expectation of a certain level of peace & quiet.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

The only possible nuisance that could be envisaged would be vandalism. However, good security and lighting outside/inside the building make such an issue highly unlikely. The reception and concierge service operate 24/7. Lighting within the hotel is appropriate for this type of establishment. CCTV assists in deterring any nuisance or vandalism.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The hotel is within the CBD and a number of restaurants and bars operate in close proximity to the hotel. Most are within a 3-4-minute drive from the hotel. Fables Christchurch is a 5-star hotel and it would be expected that people using the hotel facilities would be visiting tourist attractions within the CBD and within the wider area surrounding Christchurch. The hotel does not have any interest in guests consuming large *

The land near the hotel is occupied by commercial and retail premises. There are green spaces on Manchester Street as well as Latimer Square which is a 3-minute drive from the premises. It is reasonable to believe that the issue of this license would not change the neighbouring land use.
