**-Food:** Ensuring a range of food is easily available whenever alcohol is sold. Specifically, the menu provided.

**-Non-alcoholic refreshments:** A reasonable range of non-alcoholic drinks are available at all times including free of cost drinking water.

Ensuring that at least one low-alcohol beverage options containing 2.5% are available for sale and consumption at all times while the premises is operating.

Staff providing telephone access and calling cabs for patrons. Ensuring staff have safe transport options, especially when closing the premises.

Ensuring all staff, including new staff, are trained in host responsibility practices and the Sale and Supply of Alcohol Act 2012. Using signage that promotes moderate drinking and avoiding promotions that encourage excessive drinking

**Answer:-**

Implementing a strict policy of checking ID for anyone looking under 25.  
Displaying signage at all points of sale.

Training staff to identify signs of intoxication and refuse service.  
Providing and promoting low-alcohol and non-alcoholic beverage options.  
Offering substantial food options to counteract alcohol consumption.

. Free drinking water is available at all times when alcohol is being sold or supplied.  
. Filled jugs of water are available at the bar counter as-well-as Water is provided in jugs at the table, allowing patrons to refill their own glasses

**Answer:-**

All staff will receive initial and regular ongoing training on the Sale and Supply of Alcohol Act 2012 specifically regarding alcohol related harm deny service to intoxicated person and minors, Actively keep an eye on patrons communicate with colleague and report any unusual behavior of intoxicated person to the manager.

**Answer:-**

Noise level is Intimate up to 50dBA. We only use soft background music,

**Answer:-**

Current nuisance and vandalism levels are low. Intend to train staff to recognize potential dangers and manage unruly behavior. Comply city council restrictions, keep noise levels reasonable, join local community groups take help from neighbors.

**Answer:-**

Speights Ale House in 500 meters distance. By granting this Licence will not increase alcohol related problems as this premise is already operating quite safely as fully Licenced & BYO wine for last 11 Months.

2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

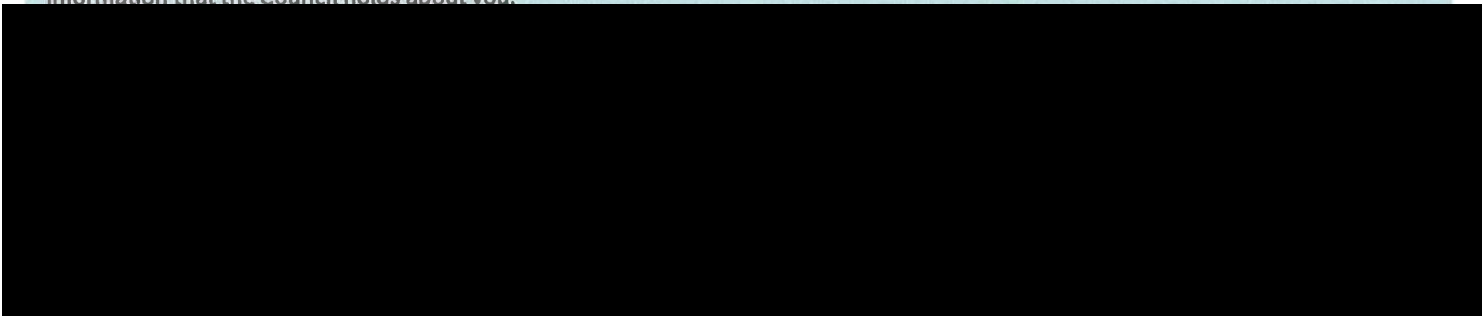
Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. Please note, your full application, including name and contact details will be used by Council staff to assess and provided to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.
