The applicant will promote responsible drinking by ensuring all staff are trained in host responsibility, checking IDs to prevent underage sales, offering low- and non-alcoholic options, avoiding promotions that encourage excessive drinking, and maintaining a safe environment for patrons.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

The applicant will ensure compliance by training all staff in host responsibility, strictly checking ID to prevent sales to minors, monitoring patrons to refuse service to intoxicated persons, and following all legal requirements under the Sale and Supply of Alcohol Act 2012.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

Drinking water will be freely available to all patrons at all times. Water will be provided by staff on request at the bar and will also be available in jugs on each table throughout the dining area.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

The applicant will ensure compliance through trained staff who have completed host responsibility courses, clear internal policies on serving alcohol, regular staff briefings, and designated management oversight to monitor adherence to the Sale and Supply of Alcohol Act 2012.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

Current noise levels are moderate and typical of a restaurant environment. In the future, noise may increase slightly during busy periods or special events. The applicant will mitigate noise by monitoring levels, keeping doors and windows closed where appropriate, and addressing any complaints promptly to ensure minimal impact on neighbours.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

Current levels of nuisance and vandalism are low. The applicant will mitigate any future risks by maintaining a safe and well-monitored environment, training staff to manage disruptive behaviour, refusing service to problematic patrons, and promptly addressing any incidents to minimise impact on the community.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

Nearby licensed premises include Dux Central and Smash, both a short distance from the location. Granting this licence is not expected to contribute to an increase in alcohol-related problems, as the premises will operate primarily as a restaurant with responsible service practices, trained staff, and a focus on moderate consumption in a controlled environment.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

The land near the proposed premises includes the stadium, AirBnB or other residential properties, businesses, and some sites under development, all consistent with the City Plan. Granting this licence is not expected to impact neighbouring land use, as the premises will operate as a restaurant in line with surrounding commercial and residential activity.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

Please note, your full application, including name and contact details will be used by Council staff to assess and provided to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.
