

Step includes training staff to recognise signs of intoxication, maintaining a phone for taxi orders and actively promoting these transport options to staff and patrons to ensure safe journeys from premises.

c. What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?

We include promoting water and other non-alcoholic alternatives, implementing strict ID checks for minors, and having procedures to handle potentially unwell or intoxicated patrons to ensure their safety.

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

These steps include staff training on age verification and identifying, a written host responsibility policy, ensure minors and intoxicated persons are not served alcohol, aligning with the goals of sale and supply of alcohol.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

We offer free water by water jugs or tap water, but must pay for soft drinks and non-alcohol drinks.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

The duty managers responsible for service of alcohol and follow host responsibility policies, staff training records with clear roles and training for all staff on detecting intoxication, identifying minors.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

The noise level at restaurant 80 dB or higher, which is harmful to hearing. It should be 60-65 dB. mitigation strategies and for the staff must have done the training and manage to especially in sensitive areas.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

A responsible manager is key to ensuring the licence condition and act requirements are followed. Understand the specific guidelines, provided by your local council or the district licensing committee, to manage amenity and licence conditions for their licence to manage issues.

12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on ccc.govt.nz/alcohol. Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
 - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
 - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence.
