We have taxi numbers available & there is a local bus service nearby. we have signs up in the service area informing patrons on options & our Host Responsibility

We have a water station & a large selection of food & non-alcoholic beverages & our staff are well trained in monitoring behaviour.

We have signs up relating ID requirement & our staff are trained in requesting ID & evaluating a Patrons suitability.

We have a fridge freely available to patrons with glasses & water. Further more glasses & water are brought to the table by a waitress in all instances when being served.

We have a staff training handbook available. All staff will be versed in the terms of our Host Responsibility statement & Regular Monitoring by Management.

We work in a business Park & we are situated within a decent distance from neighbourhoods, so noise will not be a factor. We maintain very strict operating hours. The landlord ensure noise levels are not breached to avoid issues with other tenants.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

We are into gated security Monitored Business Park, so the foot traffic is very low, from outside. Video cameras are installed, Gated before 6am & after 6pm. We are a responsible business here such as RYMAN, MSD, IRD & other corporates.

No other licenced premises in the area - as this is an existing business with a licence already it is not expected that there will be an increase in Alcohol consumption.

1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 25 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council.
