- A. We are a Supermarket and have a wide range of Alcoholic and Non Alcoholic beverages available
- B. Our Staff are happy to contact taxis for shoppers
- C. Point of sale software prompts operators to confirm age and locks the sale until a supervisor releases it. Our customer services team are trained to watch out for multiple purchases by "at risk" customers, in addition to any attempts to purchase alcohol by intoxicated or underage customers
- D. We will Display signs detailing the Statutory restrictions on the Supply of Alcohol to minors and the complete prohibition on sales to intoxicated persons
- E. For Wine Tastings we only use bottled Water
- F. We use a Web based training system – Red seed that requires all our Customer Service Team members to undergo training and the complete an online test covering the sale of Liquor
- G. New World Ilam keeps within all known District Authority Noise Levels.
- H. We have no knowledge of any deviant, antisocial and disruptive behavior resulting from the Sale of liquor at New World Ilam
- I. In the surrounding Area (Church Corner) we have licensed Restaurants, Bars and Liquor Wholesalers. New World Ilam has operated with a Liquor Licence on these premises for just under 10 years. Marc Brokenshire and Melanie Tarrant have operated New World Hokitika and New World Bishopdale and are responsible operators. The granting of this Licence will not contribute to an increase in Alcohol related problems in the area

2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

## Privacy Statement

Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

## 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
