## **9. Conditions**

**c) What other steps does the applicant propose to take aimed at promoting the responsible consumption of alcohol?**

The applicant ensures that staff are trained to recognise signs of intoxication and refuse service to underage or intoxicated customers. Staff members have access to a copy of the Intoxication Assessment Tool. Alcohol is never encouraged, sold at discounted prices, or promoted irresponsibly. There is a good range of low-alcoholic and non-alcoholic beverages available at the premises and those products are promoted/encouraged.

**d) What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?**

The current licence prohibits the applicant from selling singles of RTDs (or beers from broken cartons) (condition (i)) The applicant is further restricted from selling alcohol to young persons in school uniform regardless of their ability to produce ID (condition (j)). Alcohol will never be promoted, discounted nor advertised in an irresponsible manner. A copy of the Intoxication Assessment Tool will be displayed for staff. There will be no advertising or promotions of alcohol outside the premises except the trading name. Minors are not allowed inside the premises without a parent or legal guardian. Intoxicated persons are refused entry.

**e) To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations).**

Drinking water is freely available during any tastings.

**f) What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?**

All staff undergo regular training in order to do their job responsibly and understand their obligations to comply with the Act. The premises has CCTV for monitoring and security purposes. The premises is well lit and kept tidy. Lighting inside and outside is appropriate to check ID and monitor customers. The point of sale system have prompt reminders for staff to check customer's ID before a transaction is completed.

**g) What are the current and possible future noise levels and how does the applicant intend to mitigate them?**

Given the premises operates as a retail activity, concerns regarding noise are unlikely to arise. The applicant is not aware of any noise related concerns arising from the premises under its management.

**h) What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?**

The applicant ensures the risk of nuisance and vandalism is minimised through a combination of responsible management practices, physical security measures and active monitoring of the surrounding environment. The premises is well lit and designed to maintain clear sightlines to discourage loitering, with external lighting operating during trading hours and at night. Comprehensive CCTV coverage is installed externally and internally. Staff are trained to manage customer behaviour, refuse service where necessary, and promptly address any disorderly conduct.

Customers are encouraged to raise any concerns with a duty manager and/or directors regarding noise, nuisance, and vandalism. An incident register is kept and maintained to monitor any such concerns.

i) **What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)**

The following premises are in the vicinity of the premises (distances are given as a person would walk or travel by car):

- Liquorland Marshland – 830 metres
- New World Prestons – 812 metres
- Burwood Liquor Centre – 2 km

The premises has been operating in this locality since the grant of the licence almost 12 months ago. The applicant is not aware of any issues or concerns about the way they have managed the premises. The applicant has robust systems in place to ensure the safe and responsible sale and supply of alcohol. Given that the character, intensity, and scale of the retail activity is unchanged, it is unlikely that the renewal of the licence will lead to an increase in alcohol-related problems in the area.

j) **What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?**

The land near the premises is being used mainly for commercial/retail purposes. There are various food and beverage outlets in the same complex as the premises. There is a clothing store as well as health and fitness studio.

The nature and scale of the alcohol retail activity is consistent with the existing use of the area and will not lead to any significant changes in neighbouring land use.

Please note, your full application, including name and contact details will be used by Council staff to assess and provide to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal
