*The premises will promote responsible consumption of alcohol by offering a range of low and non-alcoholic beverages, serving alcohol with food, and refusing service to intoxicated patrons. Staff will monitor patrons' consumption and encourage pacing and food consumption*

d. What steps does the applicant propose to take to ensure that the requirements of the Act in relation to the sale of alcohol to prohibited persons (i.e. minors, intoxicated persons, other persons to whom alcohol may not be sold pursuant to the licence) are observed?

*The premises will operate a strict ID checking policy. Acceptable forms of ID include a N.Z. Driver Licence, Passport, or Hospitality N.Z. 18+ card. Alcohol will not be sold or supplied to minors or intoxicated persons. Staff are trained to refuse service when required.*

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

*Free drinking water will be readily available to patrons at all times. Water will be provided on request at the counter and jugs of water will be available within the dining area.*

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

*The premises will have clear house policies and procedures to ensure compliance with the Sale and Supply of Alcohol Act 2012. All staff involved in the sale or supply of alcohol in the sale of or supply of alcohol will receive training in host responsibility and intoxication management. The duty manager will hold a current Manager's Certificate.*

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

*Noise levels are expected to be low and consistent with a restaurant environment. Background music only will be played at moderate levels. Door and windows will be kept closed where practicable to minimise noise disturbance to neighbouring properties.*

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

*The premises will be monitored by staff at all times during trading hours. Any issues of nuisance or disorderly behaviour will be addressed promptly. Exterior areas will be kept clean and checked regularly.*

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

*There are other licensed premises in the vicinity. The granting of this licence is not expected to contribute to an increase in alcohol-related problems, as the premises operates primarily as a food and drink business with alcohol served as a secondary offering.*

*The surrounding area is used for mixed commercial purposes. The granting of this licence is not expected to adversely affect neighbouring land use, as the premises will operate within normal business hours and manage noise and patron behaviour responsibly.*

## 12. Important to note – Public notification of application

All alcohol licence application public notices are published on the dedicated webpage located on [ccc.govt.nz/alcohol](http://ccc.govt.nz/alcohol). Applications are no longer required to be published in the local newspaper.

1. We will take care of the publication of your public notice when you make your application to us.
  - There is a small administration charge for our assistance in loading the content onto the licensing notification webpage. The fee will need to be paid in advance of publication.
  - Your notice will be published within a week of your application being received and the public notice fee being paid.
2. We will send you a copy of the published notice for your records at the same time we send you the front entrance notice for display on your premises. You will need to display the notice on your main entrance for at least 15 working days.
3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

### Privacy Statement

Information contained in your application and any supporting information will be held by Christchurch City Council to enable your application to be processed under the Sale and Supply of Alcohol Act 2012. This information will be made available to the public on request as part of the public notification of your application. The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it. This information (which includes the application and all attachments) is made available to the Council's Licensing Inspectors, the Medical Officer of Health, and the Police for the purposes of monitoring ongoing compliance with any licence conditions and undertakings, Duty Manager appointments, and the Act.

The Council is required to report statistics about applications to the Alcohol Regulatory and Licensing Authority.

Any member of the public may, under the Local Government Official Information and Meetings Act 1987, request access to information held by the Council. The Privacy Act 2020 applies to the Council and under that Act, you have the right to see and correct personal information that the Council holds about you.

### 14. Important to note — Renewal with Variation Lodgement and Invoicing

Please make an appointment with an Alcohol Licensing Inspector to lodge your new renewal with variation before you make payment. The inspector will confirm your risk rating and fees and if required re-issue your invoice for payment of fees.

Renewal with Variations will not be accepted without an Inspector Verification being completed.

### 15. Processing Timelines:

Manager Certificate applications should be made well before your certificate is required. On average about 5-6 weeks is required for a standard application to allow for processing, statutory reporting on your application, and issuing of a District Licensing Committee (DLC) decision on your licence. Timelines will be longer if there are agency oppositions or missing information on your application.
