WE HAVE A WIDE RANGE OF LOW AND NON ALCHOLIC BEVERAGES. WE OFFER COMPLEMENTARY WATER AND FULL FOOD MENU AVAILABLE ALL DAY, AS WELL HAS COFFEE.

WE HAVE CERTIFIED DUTY OVERSEEING TRAINED STAFF. WE TRAIN OUR STAFF FROM INDUCTION TO ONGOING REPOSIBLE SERVICE OF ALCOHOL TRAINING BOTH INTERNALLY AND USING CLUBS NZ. WE HAVE WEEKLY MANAGERS MEETINGS.

CURRENT NOISE LEVELS ARE LOW AND WILL REMAIN SO. THE PREMISES IS ESTABLISHED BY THE WAY OF RESOURCE CONCENT AND WILL COMPLY WITH THE CONDITIONS RELATED TO NOISE.WE CHECK FOR NOISE OUTSIDE WHEN FUNCTION ARE GOING.

Current activites are low, we have roaming secerity 5 nights a week to monitor any disturbance or vandalism. we will remove any grafitti and pick up any rubbish around the club area.

Please note, your full application, including name and contact details will be used by Council staff to assess and provided to decision makers. Your application, with names only will be available on our website. However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.
