Not intoxicated person will be served alcohol. They will be removed from the premises. No person under the age of 18 will be served alcohol. Only a parent or guardian will be able to purchase alcohol for them. Uninvited guests / non-affiliated members will not be served unless they are signed in by a BWCUCCC member.

e. To what extent, where, and how is drinking water intended to be freely available to patrons? (i.e. explain whether water is bar service only, water jugs, or plumbed water stations (and locations))

The water station is situated directly in front of the bar with glasses. The tea and coffee is situated to the right of the bar and is available at all times. Bar staff will pour jugs of water and dispense to patrons at tables.

f. What appropriate systems, staff and training does/will the applicant have in place to ensure compliance with the law?

All bar staff are trained in the policies of the Club Code of Conduct, the Club Alcohol Policy, and the Club Host Responsibility Policy. DMs are trained and have current qualifications. All staff are expected to promote safe consumption of alcohol, including reducing serves per customer as the evening progresses. The focus is a safe and enjoyable environment.

g. What are the current and possible future noise levels and how does the applicant intend to mitigate them?

On a club night, noise/music is background only, and the setting promotes seated socializing, watching sport, and conversation between guests rather than loud music. When the venue is used for special functions, any live or recorded music will be turned down after 11PM and completely turned off if guests do not comply.

h. What are the current and possible future levels of nuisance and vandalism and how does the applicant intend to mitigate them?

While our venue is open, it is our responsibility to ensure that patrons are not obtaining drinks from their vehicles or congregating in the carpark area or downstairs areas to the pavilion to consume alcohol. The downstairs parts of the venue can be locked when not in use. The carpark can be viewed /monitored while the bar is open. The downstairs parts of the venue can be locked when not in use. The carpark can be viewed while the bar is open. Security cameras are in place around the venue.

i. What other licensed premises are there in the vicinity of this proposed premises? And, will the granting of this licence contribute to an increase in alcohol related problems in the area? (Explain)

The nearest licensed premises is the Burnside Rugby Club (400 m away), Burnside Tennis (100 m away), and Burnside Bowls (100 m away). None of these premises are easily accessible directly from our pavilion. We have no interactions with patrons from these venues.

j. What is the land near the proposed premises being used for? Will the granting of a licence for your premises impact on changing neighbouring land use? If so, in what way?

The premises is located off the street down a long driveway on a carpark, and overlooks the Burnside Cricket Grounds. The nearest residential homes are 200m away from the pavilion, and sheltered by large trees. The carpark and surrounding area is monitored by 24 hour security cameras, and always monitored by bar staff when the venue is open.
