Focus on dining rather than alcohol, water always available and automatically given on arrival and topped up, keeping music at a conversational level, staff training, advertising

Ongoing training of staff and Duty Managers, signage showing these persons are not permitted onsite

Water stations both inside and out on the bar top. We are a table service venue where all patrons are given water as the first step in our order of service and their glasses are replenished constantly

Employment of competent staff, bi-weekly meetings, ongoing training, email communication of any tri agency newsletters, very active messenger group chats

There are none, all antisocial challenges in our neighborhood happen outside of our hours and are not a result of our customers

Te Pae is next door, the rest of the Terrace Hospitality precinct is approximately 100m away. Our hours, offering and type of venue will not contribute to any alcohol related issues in the neighborhood

3. Except in the case of a conveyance, within 10 working days after filing this application with the District Licensing Committee, the applicant must ensure that notice of this application in form 7 is attached in a conspicuous place on or adjacent to the site to which this application relates (unless the Secretary of the District Licensing Committee agrees that it is impracticable or unreasonable to do so).

However, if requested under the Local Government Official Information and Meetings Act 1987, we may disclose applications including personal details. If you feel there are reasons why your contact details and/or personal details should be kept confidential, please contact us.

The information will be provided to the statutory reporting agencies (the Police, the Medical Officer of Health, and the Council's Licensing Inspectors) for the purposes of assessing and reporting on your application, and to the Christchurch District Licensing Committee for the purposes of making a decision on your application. This information may form part of a public hearing of your application before the Christchurch District Licensing Committee and may be used in the Committee's decision for your application. Decisions will be made publicly available.

The Council is required to keep a record of every premises licence application (including for renewals and variations) filed with the District Licensing Committee and the Committee's decision on it.
